1. Data Controller

In accordance with the Law No. 6698 on the Protection of Personal Data ("Law"), your personal data will be processed by Taha Giyim Sanayi ve Ticaret Anonim Şirketi ("Taha Giyim" or "Company") as the data controller within the scope described below.

2. For What Purpose Personal Data Will Be Processed and Legal Reason

Your collected personal data may be processed based on the following purposes ("**Purposes**") and the personal data processing conditions regulated in the 5th Article of the Law, to ensure the security of our Company campus, by recording via the closed circuit camera system and recording the visitors entering our campuses.

Based on the legal reason that data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject;

- Creating and following-up visitor records,
- Ensuring physical space security,
- Ensuring the security of movable property and resources,
- Carrying out audit activities,
- Following-up and executing legal affairs,
- Planning and conducting disciplinary, internal investigation and review processes

Based on the legal reason that it is clearly stipulated by the law and is mandatory for the data controller to fulfil its legal obligation;

- Fulfilment of official institution requests,
- Giving information to authorized institutions based on legislation,
- Management of occupational health and safety processes, execution of work accident processes,

3. To whom the processed personal data can be transferred And For What Purpose

Your personal data collected in line with the fulfilment of the above-mentioned Purposes; In accordance with the rules regarding the transfer of personal data specified in the 8th Article of the Law, within the scope of the data processing conditions regulated in the 5th Article of the Law, to the legally authorized public institutions and legally authorized private institutions within the scope of fulfilling our legal obligations and expressly stipulated in the laws.

4. Method of Collecting Personal Data

Your personal data is collected by the Company electronically through closed-circuit camera recording systems during your stay at our Company campuses, and by physical methods through the forms used during your visit to Taha Giyim and face-to-face meetings.

5. Rights of the Relevant Person Referred in the 11th Article of the Law

Regarding your personal data, we inform you that you have the following rights in accordance with the 11th Article of the Law:

- Knowing whether your personal data is processed,
- If your personal data has been processed, requesting information about it,
- To learn the purpose of processing your personal data and whether they are used in accordance with the purpose,
- Knowing the third parties to whom your personal data is transferred, in the country or abroad,
- Requesting the correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Requesting the deletion or destruction of your personal data in the event that the reasons requiring processing are eliminated, although it has been processed in accordance with the provisions of the law and other relevant laws, and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,
- Objecting to the emergence of a result against you by analyzing your processed data exclusively through automated systems,
- To request the compensation of the damage in case of incurring a loss due to unlawful processing of your personal data.

Depending on the nature of your request, your applications will be concluded free of charge as soon as possible and within thirty days at the latest; however, if the transaction requires an additional cost, you will be charged a fee according to the tariff to be determined by the Personal Data Protection Board.
